Contest Rules

- 1. **Introductory provisions.** These rules are general rules of marketing contests. Specific rules of individual contests, mainly duration of a contest, prizes, number of winners etc. will be announced to the public in an appropriate way by the announcement of the contest.
- 2. **Operator.** The operator of the announced contest is PROBINEX IKE, seated at Solonos 43, 10672 Athens, Greece, registration number 166576301000.
- 3. Conditions for participation in the contest. Only persons over 18 years of age may participate in a contest. Employees of the operator or other persons in a similar relationship to the operator, their relatives in sense of the legislation of Greece, must not participate in a contest announced by the operator. In case that one of aforementioned persons participates in a contest and wins a prize, the operator will not award the prize to such person. A single person can participate in the announced contest using only one account on the specific platform.
- 4. **Selection of a winner**. The winner of the respective prize will be drawn at random either electronically or manually. Operator reserves the right not to draw a winner, and therefore cancel the contest in part, in case a physical prize is one of the possible prizes and less than 250 persons participate in the contest.
- 5. **Handover of the prize.** The operator, after determining the winner by the method as stated in these rules, addresses the winner via a direct message via any available channel (e-mail, Telegram, etc.), declaring that this person is the winner of the announced contest and asks them how they wish to take over the prize. The prize can be handed over in person or via post. The winner is obliged to determine how they wish to receive the prize in one week from being addressed by the operator.

If the winner choses to take the prize over in person, the handover will take place at the Probinex stand at Money Show 2024 in Athens ("the event") by the end of the event. In the case of personal handover of the prize, the handover is completed by handing the prize over to the winner. In case the winner will not take over the price in person by the end of the event, they may ask the operator to send the prize via post (as described below) in seven days after the end of the event. After expiration of any deadline set in these rules the right to the prize expires.

In case the winner chooses the prize to be sent via post, the handover is completed by handing the prize over to a carrier. The costs are borne by the operator.

In case cryptocurrency were offered as the prize in a contest, the operator and the winner will proceed appropriately according to the previous paragraph. The winner is obliged to tell the address of their electronic wallet where they wished the cryptocurrency to be sent within seven days from the end of the event.

6. **Rights of the operator.** The operator is entitled to cancel, prolong, shorten, expand or restrict the duration or prizes of the announced contest any time, the operator is also entitled to amend the rules of a contest; the operator can make all the above-mentioned changes during the entire duration of the contest. The changes will be announced in an appropriate way where these rules or the specific rules of the contest are published. The operator is

entitled to decide that a prize that was not handed over to an original winner will be handed over to another winner or to no winner at all. The operator is entitled to decide to restrict the way of handing over the prize. The operator is entitled to decide whether a specific person fulfilled conditions to participate in a contest or not. The operator is entitled to exclude anyone from the contest whom he suspects of misconduct, fraud or any other action in violation with these rules or specific rules of the announced contest.

- 7. **Restrictions.** The winners are not entitled to demand another prize than the one determined by the operator for the specific winner. At the same time, the winner is also not entitled to demand any other replacement value, including money, than the prize offered by the operator. The prizes are not legally enforceable.
- 8. **Disclaimer.** Platforms Gleam.io, YouTube, Facebook, Instagram, Twitter, Telegram, Microsoft or Google serve only as a platform for presentation of the operator's contest, they are not in any way connected to the contest or the operator and the participant cannot make any claims against the operators of these platforms.
- 9. **Declaration of the participant.** By participating in the contest, the participant agrees with these rules and specific rules for the announced contest and undertakes to comply with them.
- 10. **Language and jurisdiction of the rules.** These rules are written in the English language. All legal relationships arising from an announced contest, as well as the competition itself, are governed by Greek law.

Privacy Policy

Data Controller. The operator is the controller and the processor of the personal data of the data subjects as defined below. Contact e-mail: support@earnio.com.

Processing based on the fulfilment of the contract. The operator processes personal data (identification and contact data) of persons who participate in the contest for the purpose of selection of the winner of the contest and handing over the prize. The personal data under this purpose will be processed until the winner is drawn and the prize is handed over to the winner, in any case maximum one month.

Processing based on the consent. The operator processes personal data (identification and personal data) for the purpose of marketing communication (offering products of the operator) of persons who gave their consent to this type of personal data processing. The personal data will be processed until the consent is withdrawn, maximum for one year. The consent may be withdrawn at any time via post or via e-mail.

Automatic processing. In case the draw of the winner will be performed by a computer, the processing of the personal data will be done automatically.

Consequence of not providing personal data. Without handing over identification and contact data, the data subject may not participate in the contest as the operator may not process and evaluate data subject participation in the contest. Giving consent to personal data processing is not a condition for participation in the contest, but the data subject may not be contacted with the offers of the operator's products.

Handing of personal data to third parties. Personal data will not be handed over to a third party, to the third country or to the international organisation.

Rights of Data subjects. Data subjects have the right to request from the operator access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability, to fill a complaint with the Hellenic Data Protection Authority. The rights towards the operator may be exercise via post or via e-mail
